







that we were in the hands of RAF Cosford to make the nomination. Although they had been contacted, Cosford had responded that they felt that there were no candidates of sufficient quality to warrant the award of the trophy. The Chairman asked the President to sound out the Commanding officer to determine if he still wished to keep the RAF LAA Trophy as an award for an outstanding contribution to the training machine at RAF Cosford.

He said that he did not intend to go through a catalogue of the year's events as these had been well documented in the news letter but he that he must put on record his gratitude for all the hard work done by the committee. He explained that his continuing poor health had prevented him from contributing as much as he would like. He stated that he was unable to represent the association you at the FABEA special meeting at St Clement Danes church and the annual FABEA meeting at Bedford. The Chairman thanked Vic Gibbs who ably deputised for him at both meetings, and then went on to thank Charles Hart and Tony Horry, for their efforts in organising the AGM weekend.

The Chairman then raised some issues regarding the Association. He

said "In an effort to minimise the cost of the newsletter we have investigated various sources of printing facilities and the main cost driver would appear to be the A5 sized booklet format. We could reduce the cost of production by reverting to an A4 loose leaf format but your Committee felt that the A5 booklet format was preferable and affordable. The newsletter has stimulated a quite a lively debate from a few of the members on the way we should conduct ourselves and the direction that the association should be going.. It has been commented on, that we appeared to be over-conscious of the final service rank of individuals and that our AGMs were too service orientated and consequently too long and formal. We have taken on board both of these observations, dropping the use of rank in the minutes, other than that of the president, and I will endeavour to keep this meeting as short as possible.

Two other issues were raised, with both the practice of subsidising the social functions and the purpose of the association being questioned. Although we have had only the one observation regarding the practice of subsidising the social events, as it involves the way we spend your money I felt it merited a little of AGM time to see if the view is more widely held and this will be discussed as an

agenda item during “Any Other Business.”

With regard to the purpose of the association, this is clearly stated in the constitution. However, my simplistic view of the aims of the LAA is to publicise and sustain the good image of the Locking Apprentice throughout the service and to keep alive the spirit of comradeship and fellowship that we developed and enjoyed during our training, by providing a focal point for contacting old comrades and arranging the occasional social function. To those members who question these aims, or indeed question the basic need for the association I would point out that while membership is exclusive it is not compulsory. Any voluntary organisation can only remain effective if its members believe in it and are prepared to support and contribute to the furtherance of its aims. So, at the risk of sounding trite, I will paraphrase a quote from the past and urge you all "not to ask what the Locking Apprentice Association can do for you, but rather what you can do for the Association."

In keeping with my promise to keep this AGM as short as possible, I will close on that point” The Chairman then invited the Membership Secretary Mr John Farmer, to present his report.

MEMBERSHIP SECRETARY'S REPORT.

Membership has changed only slightly over the last year. There has been an increase in numbers in the active membership, which has been countered by an increase in the numbers of resignations to give a slight increase overall, also I have to report that two members have passed away since the last AGM further depleting the active membership. I feel that some of our recruiting/membership problems are due to problems being experienced with the Appbe website (through which most of our recruiting has taken place for a number of years) and a change in the subscription ‘reminder’ documentation which has given people the opportunity to terminate their membership (for what ever reason). For those of you who like figures I offer the following: -

- We now have a total of 576 names on the Association Database (this includes both Active & Non-active members)
- An increase of 11 from last year
- There are 392 active members listed
- Down by 8 from last year
- 11 New members since the last AGM
- A fall in recruitment of 10 from 2000/2001
- 12 Members have resigned since last AGM

- A total of 29 members have resigned since the Association started
- 2 Members have passed away since last AGM
- A total of 15 members have passed away since the Association started
- There are 149 ‘non active’ or ‘ex’ members listed (this includes those resigned or deceased) An increase of 15 since last year
- There are currently 29 members who are being chased for late payment of subscriptions. About the same as last year. The ‘two reminders’ and then out procedure is now in operation.
- There are 91 names an the enquiries list
- Of these 5 are new since last year and are being actively pursued

LIFE MEMBERSHIP AND STANDING ORDERS

The number of members who are taking out Life Membership of the Association is growing. In the last year we have had 9 members take out life membership. The numbers of members paying their subscription by Standing order also grows, an additional 8 making use of this facility. I would urge those of you with a commitment to the association (and those of you, who like me want an easy life) to seriously consider making use of either of these facilities.

RECRUITMENT

Recruitment from the ‘Appbe’ web site has dried up due to problems that I will mention later. There have been a few direct referrals via members and a few from other sources, principally the Channel 4 Service Pals teletext page. As in previous years advertising in magazines and papers is proving too expensive for the return. We have been promised that the Associations details will continue to be entered into RAF News Association Register.

We are always glad to hear of any possible source of (free) advertising and will be delighted to hear from any members who may know of a possible source.

APPBE WEBSITE

For those of you who may not know the Appbe website was generated, run and owned by a past member George Burville who passed away in December 2000. The operation and care of the website was taken over by member Phil Mills. Unfortunately the direct rerouting function for membership application/enquiries failed not long after Georges demise and Phil was unable to get into the operation programming for the website to effect a repair. This was the case up until a couple of months ago when Phil made contact with George’s brother-in-law Howard Mclawhorn who it appears had

Georges computer plus software for the website. Howard it appears is prepared to take over ownership of the website and to try to run it (at least for a while until he determines both his ability to do so, and also the time needed to do so). I have been in touch with Howard by e-mail and he is working his way through the intricacies of George's passwords and setting up procedures. He hopes (?) to let us know the situation as far as the future of the website and in particular to the rerouting problem with the RAF LAA section in the very near future.

TO SUMMARIZE

Membership still grows, albeit slowly. It is hoped that the problems with the Appbe website will be resolved soon and that recruitment numbers will increase.

We have lost some members through the change in subscription reminder documentation, it is felt that it is better for members to resign if they are not happy.

We also continue to lose members through non-payment of subscriptions. In both cases we are asking ex members to let us know why they no longer wish to be members. Perhaps their answers will help us improve the Association.

On the membership front we are in reasonable shape and I commend this report to the meeting.

TREASURER'S REPORT.

The attached accounts are for the year ending 31st January 2002. These will be audited in the next few weeks.

In these accounts we see income for two AGM's, which has a considerable effect upon the annual income compared to the previous year.. The AGM due in 2000 was postponed and was held at RAP Henlow on 31st March 2001. The income for that event was £1587.50 and the expenditure was £1921.47 -a cost to the Association of £333.97, within the budget set by the Committee. Since the publication of the last newsletter, I have been receiving income for the AGM due to be held at Dauncey's Hotel, W-s-M, on 13th April. £1963 has been received as we are holding the payment due to

The meeting was asked to endorse the accounts. This was proposed by Mick Rafferty 98th Entry and Seconded by Mick Farrer 102nd Entry. The meeting voted unanimously to accept the Treasurers Report and accounts.

SUBSCRIPTIONS.

The Chairman advised the meeting that although the treasurer had already suggested that the association retain the annual subscription at £7.50, this is a decision that must be ratified by a vote at the AGM.

Joe Holroyd 85th Entry proposed that the annual subscription remained at £7-50. This was seconded by Robin White and given unanimous approval be the membership present.

PROPOSED AMENDMENTS TO THE CONSTITUTION

The Chairman stated that at the last AGM he gave notice that the committee would be proposing a change to the Constitution to enable the Association to grant Honorary Life Membership. He pointed out that the minutes of the 2001 AGM were circulated to the membership via the newsletter and there had been no notification of dissenters.

The proposal is to amend the constitution by adding the following sentence to paragraph 9.

AGM — APRIL 2002

"Honorary life membership may be granted to individual members of the association in recognition of their outstanding contribution to the association. This honour may only be granted with the unanimous approval of those members present at the AGM where the honour is proposed."

The proposal was made by Harry North 96th Entry and seconded by Mick Rafferty 98th Entry. Those members present voted unanimously in support of the proposal.

NEWSLETTER FORMAT

The Chairman stated that as mentioned by the Membership Secretary, Newsletters would continue to be distributed by both-mail and normal post but asked the membership to take up the e-mail method where possible to reduce costs. The postage being the largest percentage of the costs.

MEMBERS' PROPOSITIONS.

The Chairman informed the members present that no proposals had been received from the membership.

ANY OTHER BUSINESS.

COMMITTEE MEMBERSHIP

The Chairman then informed the meeting that nine of the ten committee posts are up for re-election before or at the next AGM. Of

these, 7 committee members have a mandate to serve until September 2002, which can be extended to the next AGM, and the other 2 until the 2004 AGM. The chairman stated that he thought that the posts of chairman and secretary are fundamental to the day to day running of the association and ideally their changeover should be staggered. He believed that his continuing ill health makes it inadvisable for him to offer to extend his term of office and the Secretary has already indicated that due to his ill health he would like to stand down as Secretary as soon as practicable although health and workload permitting he would stand for committee membership again at some point in the future.

The Chairman proposed that the membership nominate and elect replacements for both these posts today, with the new Secretary taking up office as soon as is convenient after a suitable hand over period; and the Chairman elect holding the post of deputy chairman until the next AGM, after which he would assume the chairmanship and hold it for a further 3 years. In this way the association would achieve a "one year" stagger in the two posts and provide cover for the chairman's post in the event of any sudden deterioration of his health.

The chairman called for any objections to this approach and there were none. The Chairman then asked if

CONTRA BAND IN THE GUARDROOM

Robin White (86th Entry)

Reading John Farmers excellent story of his experiences in the Locking Guardroom, reminded me that as 1st Year Apps we got our fair share of time in the Guardroom. Not, I hasten to add, as prisoners, but on the interminable picket duties (dished out to the junior entry of the day) that made up so much of our evenings and Saturday mornings across that period.

It was here that I was introduced to the staple diet of dessertspoons full of evaporated milk and sugar that we could avail ourselves of as soon as the night duty rations arrived at 9 pm. But that's another story.

The incident that I want to tell you about began on a Saturday morning. As soon as I arrived, the Guard Commander, a newly arrived Flight Sergeant, ordered me to assist him with a cell search. A member of the Locking Apprentices Pipe Band had recently been offered his own exclusive accommodation for a limited period, and had succeeded in arousing the Flight's suspicions. Having sent him down to do a spot of dirty work in the Sergeants Mess for the morning, the Guard Commander proceeded to strip and search the cell. Or rather, I carried out the heavy mattress, bedside locker and kitbags whilst he searched.

Apparently suspicions had been

aroused because prisoners were only allowed to smoke cigarettes whilst their visitors were present, but this one seemed to have an unending supply. However, despite our best efforts, the cell search turned up not so much as a Rizla paper

Undaunted the search was widened to include the toilets and ablutions. Nothing. At this point I thought the Flight was suffering a brainstorm as he started tapping the bricks of the main wall of the toilets at floor level. Suddenly with a great shout he began prising a brick out of the bottom course, then another and then, laying full stretch on the floor, he thrust his arm into the cavity that was revealed. From it he began pulling packets of tobacco and fag papers. "There's enough here to stock a shop," he said, "but it's time to put up the shutters."

Grabbing an old piece of cardboard he wrote "SHOP SHUT -RAF Locking Guard Commander", placed it in the hole, with a couple of empty tobacco and Rizla packets for good measure, and replaced the bricks.

Later that morning the prisoner returned and was watched as he disappeared into the toilets. He was watched as some while later he came out into the yard, guiltily looked around and then hurried into his cell, where a few minutes later the largest RAFP on duty extended an invitation for him to join

LOCKING BASE SOLD

The RAF Locking site on the edge of Weston has been bought in a £10 million deal.

The South West Regional Development Agency and the English Partnerships joined forces to buy the former training base from the Ministry of Defence (MOD).

The two organisations, which use Government money to help regenerate areas, say they will be looking to provide space for business, homes and communications facilities.

RDA area manager Ian Thompson said: "The RAF Locking site is an important part of the Weston Visioning exercise which is going on at the moment to determine how the town will develop over the next 20 years.

"RAF Locking needs to be considered with other major sites like Weston Airfield.

"Alongside that, we need to develop detailed plans for the site and that will take about 12 months. It's a long process. We want to involve the local business and residents in the process.

"We are having detailed discussions with the developer Persimmon Homes about how the former airfield it owns and the RAF Locking site would be developed. Hopefully we will have a strong partnership with

them.

"We want to create 2,000 to 3,000 jobs as well as building houses.

"One problem with business parks in Weston is that they have not been marketed as strongly as those elsewhere like Aztec West in Bristol. But firms are looking further south now because there is a lot of labour.

"One use of land we are not looking to have is retail. That should be concentrated in the existing town centre.

"As well as the RAF Locking site, we are also starting to talk to the council about the seafront and the piers. We have funding available for future improvements. There needs to be a total approach to the whole area.

"Weston is an important area for economic development. At the moment it is not fully reaching its potential."

North Somerset Council leader Cllr Mike Roe said: "I am really pleased the development agency and English Partnerships have taken the site on.

"The difficulty with the MOD is that it would be looking to maximise the return it would make on the site and this would have come from housing alone.

"But the agencies are working closely with North Somerset and accept our representation about the need for employment locally."

As there were no dissenters about the use of subsidies, the Chairman requested that someone propose that the Committee be mandated to subsidise social events for the association at a level which they consider fit at the time.

There were discussion about the selling of Locking and marking the site appropriately but this was continued as another AOB item.

It was proposed by David Hazel 97th and Seconded by Robin White 86th that the Chairman's suggestion be adopted and that £1000 of Association funds be allocated to the project. This was carried unanimously in a vote.
